



EMPOWERING SENIORS: EXPANDING CARE ACCESS



Continuing a legacy of providing over 125 years of exemplary care to seniors in our community

ABOUT US

Opened in 1896, Chenango Valley Home has an esteemed history of providing excellent care to senior adults in Norwich, NY. As a 501(c)3 nonprofit and a NYS licensed Adult Home, we seek to serve the surrounding areas and provide a home where seniors can continue to grow and live with independence, purpose, and dignity.

OUR MISSION

Our mission is to provide an exemplary adult residence experience in the community, fostering a balance of independence, security, and comfort for those we serve.

TIME FOR CHANGE

The ability to stay in their own homes and age in place is ultimately a goal for most seniors as they look to their future. Unfortunately, living at home is not a viable option for every senior as cost of living continues to increase, funds to maintain their homes, and access to home care is limited. Assisted Living gives adults the option to live in a home-like atmosphere and experience care that is affordable and accessible.

Chenango Valley Home seeks to expand its services by seeking NYS licensure as an Assisted Living Residence (ALR). This will allow CVH to offer enhanced services and programs to seniors who are no longer able or do not wish to remain at home. With elevated ALR licensure, individuals that would otherwise be forced to enter a Nursing Home prematurely can qualify for services in their own community. In comparison to an Assisted Living Residence, Nursing Homes are at least twice the cost and would better serve individuals who need 24-hour nursing care.

COMMUNITY CHANGES & NEED

- The model of senior care has changed, resulting in more people staying home longer.
- When it is time to consider care outside of the home, often an Adult Home is no longer an appropriate care option.
- In 2023, CVH discharged 50% of residents to higher levels of care. These residents would have been able to stay at CVH with the ALR licensure.
- In 2023, CVH declined admission to over 20 potential residents that would have qualified for care at an Assisted Living Residence.
- In 2024, 80 Nursing Home Beds were closed in Chenango County leaving a care gap for seniors in our community.

A NEED FOR RENOVATION

Over time, industry standards and NYS regulations change, requiring upgrades to the newest requirements.

In consultation with multiple architects, it has been determined that to elevate licensure to an *Assisted Living Residence* and meet future need, renovations are necessary at an expected cost of \$3 million dollars. Of that \$3 million, the facility has raised \$500,000.

Changes needed to expand our services include:

- Americans With Disabilities (ADA) compliant bathrooms
- Replacing a 1950s era elevator with an ADA compliant model.
- Renovations to meet elevated standards required by the NYS Department of Health.

VISION FOR THE FUTURE

With renovation and a change in licensure, CVH will be able to provide the following services:

- Assistance with walking, transferring, stair climbing and descending stairs, as needed.
- Intermittent or occasional assistance from medical personnel.
- Assistance with durable medical equipment (i.e., wheelchairs, hospital beds).
- Nursing care (i.e. vital signs, eye drops, injections, catheter care, colostomy care, wound care, as needed).
- The ability to serve Medicaid beneficiaries will allow an underserved community of seniors access to quality care at a 50% less cost to Medicaid than Nursing Homes.
